Dmitri M. Bondarenko holds PhD and Dr. Habil. degrees in World History and Anthropology from the Institute for African Studies, the titles of Professor in Ethnology from the Lomonosov Moscow State University, Professor in Global Problems and International Relations from the Russian Academy of Sciences, and Corresponding Member of the Russian Academy of Sciences in History. He is Vice-Director of Research, Institute for African Studies, and Director of the International Center of Anthropology, National Research University Higher School of Economics. Bondarenko's major research interests include social theory, anthropological and historical theory, political anthropology, culture and history of Africa south of the Sahara, socio-cultural transformations and intercultural interaction with special focus on Africa and people of African descent worldwide. His publications number more than 500, and include seven monographs.

Kamini Krishna is Senior Lecturer in the University of Zambia's School of Humanities and Social Sciences. Currently, she is best known for her contributions to the economic history of relations between India and Sub-Saharan Africa. She has authored three books, has presented her research findings in several different countries, and has several publications in both national and international journals.

David O'Kane is a PhD in Social Anthropology, and has researched and taught in Ireland, Northern Ireland, the United Kingdom, Russia, New Zealand, Eritrea and Sierra Leone. He is a Senior Research Fellow at Germany's Max Planck Institute for Social Anthropology, and an Honorary Fellow of the Department of Anthropology at the UK's University of Durham. His research interests include Land Reform, Nationalism, Education Policy and the Medical Anthropology of epidemics. Currently, his major research project concerns the role of language in post-conflict reconstructions of nationhood, as it was experienced in Sierra Leone.

Dr. Madia Thomson is an historian of Africa with a particular interest in the themes of environment, slavery, and social hierarchy. Her book, *The Demise of Slavery in Southwestern Morocco, 1860–2000: Economic Modernization and the transformation of Social Hierarchy*, examines these themes as a way of understanding modernization in the kingdom of Morocco. Her current work, a manuscript with the working title "A Social History of Health and Migration in Morocco", focuses on the development of a modern Moroccan system of environmental crisis management.

Hamisi Mathias Machangu is an Assistant Lecturer in the Faculty of Humanities and Social Sciences at the Dar Es Salaam University College of Education (DUCE), Tanzania, where he teaches history. He is currently completing his doctoral studies at the University of Dar es Salaam, where he is working on the topic of ethics in drug trials on human subjects in Tanzania. He has a Master's degree in history, based on research on the history of malaria and its control in British colonial Tanganyika.

Jean-Claude Meledje got his doctoral degree in International Relations and Politics from Flinders University, Australia, for a dissertation on the ongoing crisis in Cote d'Ivoire. At present, Jean-Claude works at the Federal Department of Industry, Innovation and Science in Canberra as a Policy Officer, providing policy advice on emerging and cross-cutting policy issues. Part of the work includes closing the gap for Indigenous people, immigration and energy policy. Jean-Claude attends seminars at the Institute for Governance and Policy Analysis, University of Canberra. Issues range from climate change to deliberative democracy.
